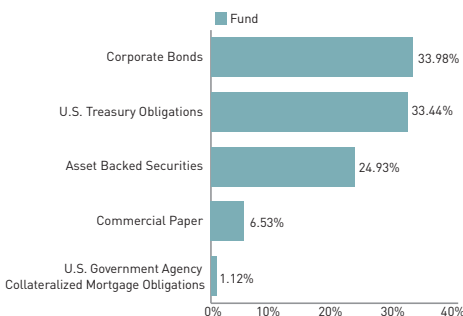

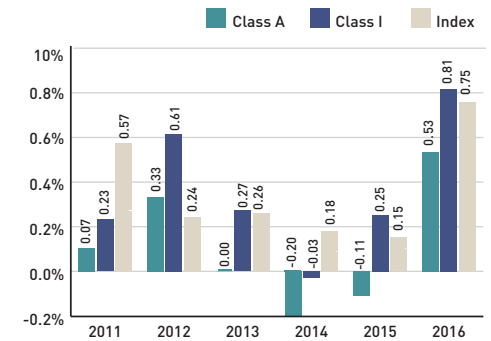

**INVESTMENT STRATEGY**

The PNC Ultra Short Bond Fund is managed through a team-driven, top-down process utilizing active sector rotation, duration and yield curve management, with extensive credit research and portfolio analysis to mitigate risk. The Fund seeks to provide high current income, while preserving capital by primarily investing in investment-grade securities including U.S. government, mortgage-backed and asset-backed fixed income securities and corporate bonds. The dollar-weighted average maturity of the Fund is expected to be less than 18 months.

**INVESTMENT RISKS**

An investment in the Fund is subject to interest rate risk, which is the possibility that a fund's yield will decline due to falling interest rates and the potential for bond prices to fall as interest rates rise. High yielding, non-investment-grade bonds present a greater risk of loss to principal and interest than investment grade securities. The value of debt securities may be affected by the ability of issuers to make principal and interest payments and even the possibility that the issuer will default completely.
